"ORDER AMENDING EXECUTIVE ORDER NO. 8, SERIES OF 2019 PROVIDING FOR THE CREATION OF PROVINCIAL ECOLOGICAL SOLID WASTE MANAGEMENT BOARD (PESWMB) OF THE OCCIDENTAL MINDORO, DEFINING ITS DUTIES AND FUNCTIONS AND FOR OTHER PURPOSES"

WHEREAS, it is a declared policy of the State to adopt a systematic and comprehensive solid waste management program which, amongst others, shall ensure the protection of public health and the environment;

WHEREAS, Section 16, Article II of the 1987 Philippine Constitution provides that the State shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature;

WHEREAS, Republic Act 9003, otherwise known as the "Ecological Solid Waste Management Act of 2000" was enacted providing for an ecological solid waste management program, creating the necessary institutional mechanisms and incentives, declaring certain acts prohibited and providing penalties, appropriating funds therefor, and for other purposes;

WHEREAS, pursuant to the relevant provision of Republic Act No. 7160, otherwise known as the "Local Government Code", the Local Government Unit shall be primarily responsible for the implementation and enforcement of the provisions of the Ecological Solid Waste Management Act of 2000;

WHEREAS, Executive Order No. 8 series of 2019 was enacted providing for the creation of the Provincial Ecological Solid Waste Management Board (PESWMB) of the Occidental Mindoro, defining its duties and functions and for other purposes;

WHEREAS, in compliance with the provisions of the aforementioned laws, a Provincial Ecological Solid Waste Management Board shall be established in every province with updated composition, to be chaired by the Governor;

NOW, THEREFORE, I, EDUARDO B. GADIANO, Governor of the province of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. CREATION.

It is hereby amended and updated the existing Provincial Ecological Solid Waste Management Board (PESWMB) of the Province of Occidental Mindoro purposely for the implementation and enforcement of the provisions of Republic Act 9003, amending Executive Order No. 8, series of 2019.

SECTION 2. COMPOSITION.

The Board shall be composed of the following, in accordance with Republic Act 9003:

SECTION 3. DUTIES AND FUNCTIONS.

The Provincial Ecological Solid Waste Management Board shall have the following Functions and Responsibilities:

1. Develop a provincial ecological solid waste management plan from the submitted solid waste management plans of the respective eleven (11) Municipal Solid Waste Management Boards. It shall review and integrate the submitted plans of the respective Planning and Development Office, perform overall coordination of CBMS implementation activities in the province and provide management support to the PTWG and spearhead in the creation of municipal TWG;
2. Develop an appropriate incentive scheme as an integral component of the provincial SWM plan;
3. Recommend measures to generate resources for the implementation of projects and activities as specified in the approved SWM plans;
4. Provide the necessary assistance in providing technical support in data generation and analysis particularly in agriculture-related indicators;
5. Recommend measures and safeguards against pollution and for the preservation of the national ecosystem;
6. Coordinate the efforts of the component municipalities in the implementation of the Provincial Ecological Solid Waste Management Plan;
7. Develop an appropriate incentive scheme as an integral component of the Provincial Ecological Solid Waste Management Plan;
8. Convene joint meeting of the Provincial and Municipal Solid Waste Management Boards at **least quarterly** for purpose of integrating, synchronizing, monitoring and evaluating the development and implementation of its provincial solid waste management plan;
9. Represent any of its component municipality in coordinating its resource in operational requirements with agencies of the national government;
10. Oversee the implementation of the Provincial Solid Waste Management Plan;

11. Review every two (2) years or as the need arises, the Provincial Ecological Solid Waste Management Plan for purposes of ensuring its sustainability, effectiveness and relevance in relation to local and international development in the field of solid waste management; and

12. Provide assistance to 11 municipalities of Occidental Mindoro in the implementation of RA 9003 by:

- a. Provide necessary logistical/operational support to its component cities and municipalities in consonance with the Local Government Code;
- b. Identify areas within its jurisdiction that have common SWM problems and are appropriate units for planning local SWM services;
- c. Allow the clustering of LGUs for the solution of common SWM problems;
- d. Represent any of its municipalities in coordinating its resource and operational requirements with agencies of the national government.

SECTION 4. SEPARABILITY CLAUSE.

If any section or provision of this Order is held unconstitutional or invalid, any other section or provision not affected thereby shall remain valid and effective.

SECTION 5. REPEALING CLAUSE.

All orders, rules and regulations inconsistent with the provisions of this Act are hereby repealed or modified accordingly.

SECTION 6. EFFECTIVITY CLAUSE.

This Order shall take effect immediately and shall remain in force until expressly revoked.
