



EXECUTIVE ORDER NO. 15

Series of 2019

“PROVIDING FOR THE RE-ORGANIZATION OF THE PROVINCIAL ANTI-DRUG ABUSE COUNCIL IN THE PROVINCE OF OCCIDENTAL MINDORO”

WHEREAS, the Constitution of the Republic of the Philippines mandates that the government shall promote the quality of life of the people;

WHEREAS, towards this end, Section 16 of the Local Government Code of 1991 provides that local government units shall pursue undertaking to improve public morals and maintain peace and order, among other equally significant concerns;

WHEREAS, there is an increasing use of illegal drugs which has significantly contributed to the incidence of heinous crimes;

WHEREAS, the problem in illegal drugs has to be addressed much more effectively to ensure community peace and harmony;

WHEREAS, DILG-DDB Joint Memorandum Circular No. 2018-01 has for its overall objectives the following:

1. Set the minimum standard functionality and effectiveness of local anti-drug abuse councils that covers all provinces, cities, municipalities, and barangays;
2. Harmonize the inter-operability of all Anti-Drug Abuse Councils (ADACs) at all levels;
3. Systematize an effective ADAC monitoring and reporting mechanism; and
4. Set performance indicators of a functional ADAC as measurement of effectiveness in support to the reduction of drug affectation.

NOW, THEREFORE, I, EDUARDO B. GADIANO, Governor of the Province of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order the re-organization of the Provincial Anti-Drug Abuse Council in the Province of Occidental Mindoro.

SECTION II. Roles and Responsibilities. The Provincial Anti-Drug Abuse Council shall perform the following roles and responsibilities:

1. Ensure the formulation of PADAC Action Plan that contains the PPAs identified in the Municipal ADAC Action Plans;
 - (a) Organize the PADAC Drug Reformation Committee and adopt the Program of Instructions for Drug Reformation Program;
2. Approve substantial amount of budget;
3. Ensure the functionality of the lower ADACs;
4. Conduct of regular meetings once a month;
5. Analyze and review reports submitted by MADAC Secretariat;
6. Submit all collated quarterly reports to the RPOC Secretariat not later than the 15th day of the ensuing quarter, copy furnished the Provincial Peace and Order Council and the DILG Provincial Office;
7. Ensure the establishment and operation of the Special Drug Education Center for out-of-school youth (OSY) and street children; and
8. Provide support for the operationalization of the Community-Based Rehabilitation Program at the Municipality and Component Cities.

SECTION III. Source of Funds. Financial requirements for the activities and projects of the Provincial Anti-Drug Abuse Council shall be chargeable against the 20% Development Fund of the Province.

SECTION IV. Effectivity. This Executive Order shall take effect immediately.

SECTION II. Roles and Responsibilities. The Provincial Anti-Drug Abuse Council shall perform the following roles and responsibilities:

SECTION III. Source of Funds. Financial requirements for the activities and projects of the Provincial Anti-Drug Abuse Council shall be chargeable against the 20% Development Fund of the Province.

SECTION IV. Effectivity. This Executive Order shall take effect immediately.
