



EXECUTIVE ORDER NO. 30

CREATION OF UNIFIED PROVINCIAL INTER-AGENCY ADVISORY COMMITTEE (PIAC) FOR THE IMPLEMENTATION OF THE 3 CORE SOCIAL PROTECTION PROGRAMS OF THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD): THE KAPIT-BISIG LABAN SA KAHIRAPAN—COMPREHENSIVE AND INTEGRATED DELIVERY OF SOCIAL SERVICES (KALAHI-CIDSS), PANTAWID PAMILYANG PILIPINO PROGRAM, SUSTAINABLE LIVELIHOOD PROGRAM (SLP), AND OTHER COMMUNITY-BASED SOCIAL PROTECTION PROGRAMS

WHEREAS, Section 16 of Republic Act 7160 otherwise known as the Local Government Code of 1991 states that “Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare.”;

WHEREAS, the Provincial Government of Occidental Mindoro is committed to promote the welfare of its people through good governance, transparency and accountability in the delivery of basic services to the people;

WHEREAS, the Provincial Government in support to the Department of Social Welfare and Development’s 3 Core Social Protection Programs namely: Pantawid Pamilyang Pilipino Program, KALAHI-CIDSS, and the Sustainable Livelihood Program, and other community-based social protection in the province, finds imperative that it should be accountable and responsible to ensure proper implementation of the program in the province;

WHEREAS, the Department of Social Welfare and Development’s core programs aim for the local community to have a continuing access to basic needs and social services. Thus, the community members are empowered and participative in community-based protective services and assessment towards poverty reduction;

WHEREAS, there is a call for convergent action to maximize, harmonize and synchronize the processes involved and resources allocated for the implementation of the social protection programs to reduce duplication of efforts and strategies of DSWD workers, and develop partnership among its partner agencies for realization of this strategy at the provincial level where the beneficiaries are located;

WHEREAS, there is a need to create a Provincial Inter-Agency Advisory Committee (PIAC) which will serve as partner in the implementation of the 3 Core Social Protection Programs and other community-based social protection programs of the DSWD in the Province of Occidental Mindoro;



NOW THEREFORE, I, EDUARDO B. GADIANO, Governor of Occidental Mindoro, by virtue of the powers vested in me by law and the Occidental Mindoro electorate, do hereby ORDER, as follows:

Section 1. Creation of the Provincial Inter-Agency Advisory Committee (PIAC) on the Three Core Protection Programs and Other Community-Based Social Protection of DSWD in the Province of Occidental Mindoro. The Provincial Inter-Agency Advisory Committee is hereby created.

Section 2. Composition. The Provincial Inter-Agency Advisory Committee (PIAC) shall be composed of the following:

The abovementioned employees of the Department of Social Welfare and Development (DSWD) in the province shall act as the Secretariat of the Committee to record, prepare minutes, notices and other documents as needed by the committee.

The Provincial Social Welfare and Development (PSWD) Office shall act as support staff to the secretariat.

Section 3. Duties and Responsibilities. The Provincial Inter-Agency Advisory Committee (PIAC) shall perform the following duties and responsibilities:

- a. Ensure smooth implementation of specific operational guidelines of the Pantawid Pamilyang Pilipino Program, Sustainable Livelihood Program and the Kalahi-CIDDS, and other community-based social protection programs;
- b. Coordinate the implementation/operationalization of sectoral activities to better execute program objectives and functions;
- c. Review and resolve all provincial concerns and requirements needing actions;
- d. Ensure that the supply side on health and education is available at the target municipalities;
- e. Serve as the Provincial Grievance Committee; address grievances, queries and complaints that are elevated to the provincial level; institute measures and formulate rules and guidelines, as may be necessary;
- f. Coordinate with all concerned agencies on all matters related to DSWD Programs' implementation;
- g. Hold regular quarterly meetings or as the need arises;
- h. Review and resolve all provincial concerns and refer higher level problems in need of action to the regional level and provide feedback.
- i. Enable Livelihood Opportunities for the identified partner beneficiaries of the Social Protection Programs through creation of relevant policies.

Section 4. All orders or memoranda that are in conflict with the provisions of this order are hereby ordered rescinded, superseded and/or modified accordingly.

Section 5. Effectivity. This order shall take effect immediately.
