



EXECUTIVE ORDER NO. 35
Series of 2019

PROVIDING FOR THE CREATION OF THE HEALTH CARE PROVIDERS' NETWORK (HCPN) TECHNICAL WORKING GROUP (TWG) OF OCCIDENTAL MINDORO, DEFINING ITS DUTIES AND FUNCTIONS, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES

WHEREAS, Republic Act No. 11223 or the Universal Health Care (UHC) Act ensures that all Filipinos are health literate, provided with healthy living conditions and protected from hazard and risks that could affect their health;

WHEREAS, this Act ensures that all Filipinos are guaranteed equitable access to quality and affordable health care goods and services and protected against financial risk;

WHEREAS, the Province of Occidental Mindoro is in the preparatory phase defining the referral mechanism, case categorization and finalization of referral guidelines;

WHEREAS, to ensure functionality and sustainability of the Health Care Providers' Network (HCPN), a core team of representatives from member facilities and organizations must be organized into a Technical Working Group (TWG) to manage the network and oversee compliance with the agreed terms under the technical integration;

NOW, THEREFORE, I, EDUARDO B. GADIANO, Governor of the Province of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. Creation of the Technical Working Group (TWG). There shall be a Health Care Providers' Network (HCPN) Technical Working Group (TWG) of Occidental Mindoro.

SECTION 2. The composition of the Technical Working Group shall be as follows:

SECTION 4. Roles and Functions. The Technical Working Group (TWG) shall have the following roles and functions:

The TWG should provide over-all leadership by setting the operational direction to guide and direct the annual activities of the HCPN; ensuring the effective management of the HCPN and its activities; and monitoring the activities of the HCPN and its member facilities to ensure their compliance with the agreed upon referral mechanism, particularly:

4.1 Management

- Decides on who becomes a member of the HCPN;
- Secures funding support to HCPN activities; and
- Addresses operations and management concerns (e.g. discusses with LCEs the needs of member facilities including transportation, human resource, logistics, etc.).

4.2 Technical Support

- Provides technical guidance on HCPN operations (source out possible TA provider);

- Provides clinical expertise particularly on clinical protocols and standards;
- Coordinates with other agencies (e.g. DSWD, DepEd, PopCom, etc.) for technical assistance needed by member facilities; and
- Facilitates conduct of capability building activities for health service providers as necessary.

4.3 Human Relations

- Addresses relational issues and concerns among member facilities.

4.4 Monitoring and Evaluation

- Ensures compliance with the agreed referral guidelines;
- Provides a venue for discussing incident reports;
- Leads the conduct of monitoring and evaluation workshops; and
- Conducts facility level monitoring and coaching.

SECTION 5. Meetings. The Technical Working Group shall meet quarterly or as needed and apprise the Governor on the status of the HCPN UHC activities.

SECTION 6. Effectivity. This Order shall take effect immediately.
