# EXECUTIVE ORDER NO. 38

Series of 2019

PROVIDING FOR THE CREATION OF TECHNICAL WORKING GROUP (TWG) FOR THE CRAFTING AND FORMULATION OF THE OCCIDENTAL MINDORO AGRICULTURAL AND FISHERIES DEVELOPMENT PLAN – 2021-2025 FOR THE ENHANCEMENT OF SUSTAINABLE SOCIO-ECONOMIC GROWTH, DEVELOPMENT AND PRODUCTIVITY

WHEREAS, the economy of the province of Occidental Mindoro is primarily propelled thru Agricultural and Fishery production that should be sustained for its continuing contribution to the Food Security and Food Self-Sufficiency Program of the Government and cater for poverty alleviation and socio-economic upliftment in the local communities and in the province;

**WHEREAS**, sustainability of the Agri-Fishery productivity could be attained/achieved thru the adoption and implementation of an effective and efficient plans, programs, strategies and policy directions;

**WHEREAS,** the Province of Occidental Mindoro has to develop its own Agriculture and Fisheries Development Plan to achieve the following objectives:

- a. To identify issues and constraints affecting the Agri-Fishery productivity;
- b. To establish right and appropriate directions for sustainable socio-economic development and inclusive growth;
- c. To determine possible, workable and manageable project interventions that will help address identified issues and constraints;
- To guide the concerned implementers of Plans, Programs, and Strategies for better outcome/results;
- e. To sanitize and prioritize projects for implementation; and
- f. To complement the Agri-Fishery Road Map of the province.

WHEREAS, the crafting and formulation of the entire Agriculture and Fisheries Development Plan should be done thru the collaboration of line offices/agencies coming from different Local and National Government Agencies together with some institution from private sectors;

WHEREAS, the Provincial Government of Occidental Mindoro, thru the Honorable Governor EDUARDO B. GADIANO, is responsible for the institutionalization of the created TECHNICAL WORKING GROUP (TWG) thru the issuance of Executive Order for its legal and binding tasks in formulating and crafting the Occidental Mindoro Agricultural and Fisheries Development Plan 2021-2025;

NOW THEREFORE, I, EDUARDO B. GADIANO, Governor, Province of Occidental Mindoro, by virtue of the powers vested in me by law, do hereby create the OCCIDENTAL MINDORO TECHNICAL WORKING GROUP (TWG) for Crafting and Formulation of the Occidental Mindoro Agricultural and Fisheries Development Plan — 2021-2025 for the enhancement of Sustainable Socio-Economic Growth, Development and Productivity:

#### SECTION II. ROLES AND FUNCTIONS OF TECHNICAL WORKING GROUP (TWG)

The Technical Working Group as herein created shall be responsible for the following tasks:

- Develop/formulate the Occidental Mindoro Agricultural and Fisheries
   Development Plan 2021-2025 and its financial requirements to fund the
   identified project interventions stipulated thereon and submit the same to the
   Provincial Governor's Office and Sangguniang Panlalawigan for review, approval,
   and adaptation prior to implementation;
- 2. Link investment and entrepreneurial promotion and access to financing;
- 3. Provide capacity development to improve Agri-Fishery productivity to enhance socio-economic upliftment and poverty reduction;
- 4. Advocate and support existing enabling environmental policy;
- 5. Promote to the LGUs adaptive management system with incentives and science based technical assistance to enhance local knowledge and capabilities;
- Conduct Monitoring and Evaluation on Agri-Fishery Development and accomplishments in the municipal and barangay level prior to updating of the Plan and prepare Annual Reports for filing and submission to the Provincial Governor and to the Sangguniang Panlalawigan; and
- Perform such other duties as may be deemed necessary or as prescribed by the Provincial Governor.

## **SECTION III. MEETINGS**

The Occidental Mindoro Technical Working Group (TWG) for the crafting and formulation of the Occidental Mindoro Agricultural and Fisheries Development Plan - 2021-2025 shall be called whenever necessary.

#### SECTION IV. FUNDING REQUIREMENTS

Transportation expenses and meetings costs will be allocated by concerned agencies/offices.

#### SECTION V. EFFECTIVITY

This Order shall take effect immediately.
